Mr. Murch retired from the Cushman Baking Co. in 1953.

He was a 50-year member of the Masons and the Kora Shrine Temple, a director of the Portland Boys Club, a former member of the Woodfords Club and the Portland Club, and the Woodfords Congregational Church.

His first wife, Isabel Brown Murch, died in 1918. His second wife, Doris Strout Murch, died in 1989.

Kenneth N. Murch, 89, died Sunday in a Falmouth nursing home.

He was born in Rockland, son of Fred L. and Almira Nichols Murch, attended schools in Unity and graduated from Freedom Academy.

Mr. Murch began his career in banking at City National Bank of Belfast. He then worked for the Treasury Department in Washington, D.C., as a national bank examiner for 14 years. Until his retirement, he worked for First National Bank of Brunswick, which then merged with Maine National Bank of Portland. He retired in 1972 as a vice president.

He moved here in 1942.

Mr. Murch attended Woodfords Congregational Church. He was a member of the Masons in Belfast and a former member of the Grange and the Brunswick Rotary Club.

His first wife, Lorene Bessey Murch, died in 1983. His second wife, Euna Bean Murch, died June 21.

Surviving are a niece, Mary Bessey of Palmyra; a nephew, Ithamar Bellows of Henderson, S.C.; and several cousins.

Unity College named a road on campus after him, Murdock Drive, to represent what he had done in the formative years of the college to keep it prospering.

George learned how to fly and bought a twin-engine plane. He earned all available licenses to make him a better pilot. He flew with his family to many places. He loved the

sea still foremost. He started sailing and after 10 years he changed to power boating. He took many safe boating courses with the U.S. Power Squadron, and taught many courses as well. He received his Coast Guard captain's license in 1990. He was past commander of the Power Squadron.

He loved and was a member of the Unity Union Church and was very active for many years serving on various committees. He was a 55-year member of the Masons and was a member of the Rotary. George loved God, family, his country, music, boating and traveling. He was always smiling and will be remembered for his sense of humor and quick wit. He will be greatly missed.

George is survived by his wife of 58 years, Beverly (Newell) Murdock, Unity; his children, Steven N. Murdock and his wife, Lucia R., of Annapolis, Md., Wendy Esposito and her husband, Robert, of Unity, Scott S. Murdock and his fiancée, Mary-Jo Neal, of Burnham, and George H. Murdock V and his wife, Holly-Jo, of Newport; his sister, Carol Nicoson and her husband, Ronald, of Florida; seven grandchildren, two step-grandchildren, and five great-grandchildren, all whom he dearly loved.

He was generous, dependable, and a wonderful provider for his family.

A memorial service will be held at 2 p.m. Saturday, Jan. 10, at the Unity Union Church, with the Rev. Rick Boyden officiating. Contributions in his memory may be made to the Unity Union Church, P.O. Box 146, Unity, ME 04988.
