Walter Frederick Murrell lawyer and municipal court judge

Walter F. Murrell, a former Portland Municipal Court judge and member of the law community for 60 years, died Friday evening at the Barron Center. The former Webb Street resident was 93.

Family members described him as distinguished lawyer and judge, as well as a devoted family man.

"He was a highly principled man," said Lorna W. Pillsbury Murrell, his wife of 44 years. "He was willing to go the extra mile for people whether they were his family, neighbors or clients. He was a good listener, cared about people, and had a lot of respect for them. He was a super man."

Mr. Murrell was born in Portland, son of John Frederick and Bertha Lynch Murrell, attended Hebron Academy and graduated from Deering High School. He fur-

thered his education at Gray's Business School and later graduated from Peabody Law School.

In the late 1920s he began practicing law for what would turn out to be a 60-year career. He was associated with Elton H. Thompson and after Thompson's death, became part of the firm of Wilson, Steinfeld and Murrell. As a young attorney he volunteered many hours of his time as an adviser to the American Red Cross and Child and Family Services.

In the late 1950s, then Gov. Edmund S. Muskie appointed him associate judge of the Portland Municipal Court, and he continued in that capacity into the late 1960s under Gov. John H. Reed. career Judge Murrell worked in general and probate law.

Each day the newspaper selects one obituary and seeks to learn more about the life of a person who has lived and worked in Maine. We look for a person who has made a mark on the community or the person's family and circle of friends in small but lasting ways.

"He worked through his mid-80s. He was a man who wanted to be busy," Mrs. Murrell said.

Lorna Murrell said his caring and generosity were extended first and foremost to his family. He often spoke of how proud he was of his parents, and how he loved his brothers, sisters and children. The family, in return, loved him and relished his keen sense of humor, which was expressed even as his health failed, she said.

Because his father died at an early age, the family was very close and worked selflessly to help each other attain professional degrees.

His wife said Murrell rarely took vacations, but when he did get away, one of his greatest joys was to plan fishing trips to the Allagash and St. John River areas.

Mrs. Murrell said her husband also possessed a spirit of volunteerism that extended beyond the family to the community. During World War II he served as a lookout for German submarines in Portland Harbor at the Portland Observatory.

Later, Murrell was a member of the Cornerstone Masonic Lodge and was its Worshipful Master in 1944-45. He also joined the Kora Temple Shrine of Lewiston.

In his youth Mr. Murrell was a member of the St. Luke's Cathedral, and later became an active member of Trinity Episcopal Church.

Surviving, besides his wife of Portland are two sons, Walter J.W., M.D., of Amarillo, Texas, and Maj. Stephen Pillsbury Murrell, D.D.S., stationed in the Azores, Portugal, with the Air Force Dental Corps.; two granddaughters, Nora and Madeleine Murrell; one grandson, Steven Joe Murrell; a niece, Elizabeth Halpern of Hampden; a grandniece Robin, and two grandnephews Gregory and Andrew, as well as several cousins.

Visiting hours will be from 2 p.m. to 4 p.m. and from 7 p.m. to 9 p.m. Wednesday at the Jones, Rich & Hutchins Funeral Home, 199 Woodford St. Burial Office and the Eucharist will be celebrated at 11 a.m. Thursday at Trinity Episcopal Church, Forest Avenue and Coyle Street.
