"I was holding onto the rail with one hand and my brother by the scruff of the neck with another," she recalled. "He had to wait for the next swell. I thought it was real neat the way my dad got us out of that situation, no problem."

He was born in Penobscot, son of John H. and Harriet C. Littlefield Quinn, and attended school on Eagle Island. After his father died, he helped his mother operate the Quinn House on Eagle Island

at the age of 16.

The hotel closed in 1931, and he became captain of the private yacht "Hippocampus" for the Porter family of Great Spruce Head Island for many years. Capt. Quinn also served on several other private yachts for notable families in the area.

He was a member of Marine Masonic Lodge, Deer Isle, and the York and Scottish Rite Bodies. He also was a member of Kora Temple Shrine and was an honorary member of Mid-Coast Shrine Club.
