LINCOLN — David F. Stevens, 67, died unexpectedly Nov. 5, 1992, at a Lincoln hospital. He was born in Lincoln, Nov. 24, 1924, the son of Harry B. and Dorothy (Ayer) Stevens. David was a graduate of Mattanawcook Academy. He served in Europe as an airplane mechanic in the Army Air Corps during World War II. After his discharge, he completed his education at Worsham College of Mortuary Science in Chicago and became a licensed funeral director and embalmer. He was employed at the Barton Funeral Home and also at H.B. Stevens Clothing Store during his early career. In 1963, he became a partner at the Barton Funeral Home. In 1972, the Barton Funeral Home and the Clay Funeral Home were purchased by Clay, Stevens & Clay, Inc., of which David was vice president, a position he held until his retirement on Dec. 31, 1989. He had been a Boy Scout committeeman; a member of the Maine Funeral Directors Association, Horeb Lodge No. 93 AF & AM, the Lincoln Congregational Church and

the Congo Men's Club. David was an avid outdoorsman who enjoyed camping, hunting and fishing. He is survived by his wife, Mary (Fitzherbert) Stevens; one son, Christopher of Lincoln; two daughters, Deborah McCafferty of Farmington and Patricia Murchison of Lincoln; six grandchildren, Angela McCafferty, Andrea McCafferty, David McCafferty, Ryan Stevens, Jason Murchison and Timothy Murchison; three brothers, Joseph of Portland, Galen of Lincoln and Clifford of San Antonio, Texas; several nieces, nephews and cousins. Friends may call 2-4 and 7-9 p.m. Sunday at the Clay, Stevens & Clay Funeral Home. Funeral services will be held 1 p.m. Monday at the funeral home with the Rev. Jeffrey Moody officiating. DAVID H. STEVENS

HALLOWELL — David H. Stevens, 82, former commissioner of the Maine Department of Transportation, died Aug. 6, 1989, at his home of 18 Maple St. He was born in Guilford, Jan. 31, 1907, the son of James B. and Cora H. (Herring) Stevens. He earned his B.S. degree in civil engineering from the University of Maine at Orono in 1928. He then taught at the University for a year, before joining the New York Telephone Co. for three years. After employment as town manager in Ashland, Guilford and Milo, he was appointed state tax assessor by Governor Sumner Sewall. Five years later, he was appointed commissioner of health and welfare, where he served for seven years. In 1954, Mr. Stevens was appointed first full-time chairman of the state's Highway Commission. He held that position until the early 1970's, when the Highway Commission was reorganized into the Department of Transportation. Governor Curtis then appointed him Maine's first commissioner of transportation. After his retirement from the Department of Transportation in December of 1973, Mr. Stevens became the ad-

ministrative head of the Maine Turnpike Authority, a post he held until his retirement in Fall of 1987. The David H. Stevens Award was established this year, to be awarded for the transportation excellence at the annual transportation conference for outstanding individuals in the organization. He was a member and past president of the American Association of State Highway Officials; a member and past president of the Association of Highway Officials of the North Atlantic States; and former chairman of the Highway Research Board. Mr. Stevens received many awards and recognition for his outstanding service in highway engineering. He received the distinguished service award from the University of Maine and was named one of the top ten public works officials in the nation in 1973 by the American Public Works Association. In 1987, the Maine Turnpike Authority headquarters building in Portland was named the David H. Stevens Building. He was a member and past officer of the Maine Good Roads Association and a 50-year member and past officer of the Guilford Lodge of Masons. His wife of more than 55

years, Dora (Wilson) Stevens, died March 25, 1985. He is survived by two daughters, Jane Harvey of Hallowell and Joan S. Paulin of Indianapolis, Ind.; one sister, Charlotte Crookson of Guilford; six grandchildren, three great-grandchildren, one uncle and two nephews. A memorial service will be held 10 a.m. Wednesday at the Old South Congregational Church, Second Street, Hallowell. Arrangements by Knowlton & Hewins Funeral Home, 68 Second St., Hallowell.

EARLE D. STEVENS

BREWER — Earle D. Stevens, 59, husband of Gertrude (Dyer) Stevens, died at his home Feb. 14, 1991. He was born Feb. 24, 1930, in Bangor, the son of Archie and Ada (Arnold) Stevens. A 1948 graduate of the Higgins Classical Institute, he held a B.A. and M.A. from the University of Maine. He had been treasurer of the Class of 1953, a member and treasurer of the Rho Rho Chapter of Sigma Chi Fraternity, later serving as treasurer on the Rho Rho Chapter House Association. He served in the U.S. Navy after graduation. He was administrative assistant to the Board of Selectmen of New Canaan, Conn. from 1953-57, town manager of Scarborough from 1957-65, city manager of Brewer from 1965-81, city manager of Ellsworth from 1981-89 and interim manager of Pittsfield, director of finance and administration of the Department of Transportation until he became disabled. He was a member of the Patrons of Husbandry of Charleston and New Canaan, Conn., the Rotary Club of New Canaan, Conn., the Lions Club of Scarborough, the Maine Tax Collectors Association, I.C.M.A., the Board

of Directors of the Greater Bangor Community Action Agency, past president of the Kiwanis Club of Brewer, past president of the Maine Town and City Managers Association, from which he was the first recipient of the Manager of the Year Award in 1977. He worked with the Bureau of Public Administration of the University of Maine, often serving as a speaker for the American Legion Boys State and had been nominated by the Scarborough Jaycees for Outstanding Young Man of the Year Award. He was also a member of the First United Methodist Church of Brewer, serving as lay-leader and on the advisory board of Ralph J. Pollard Lodge AF & AM of Orrington and Anah Temple Shrine of Bangor. Surviving, in addition to his wife, are his parents of Skowhegan; three daughters and sons-in-law, Kathy and Robert Dunlap of Herndon, Va., Patricia and Michael Alley of Northport, Linda and Scott Babbidge of Brewer; four grandchildren, Daniel and Laura Dunlap, Justin and Christopher Alley; one brother and sister-in-law, Lester and Elizabeth Stevens of Dover-Foxcroft; two sisters and one

brother-in-law, Barbara and David Leavitt of St. Albans, Alice Glover of Skowhegan; several aunts, uncles and cousins. He was predeceased by a grandson, Matthew Alley. — George Newhall Stevens, 93, widely-known resident of Southern Maine, and for many years a hotel proprietor, died today in a convalescent home at Kennebunk. He had been a patient there the last year.

Mr. Stevens, former legislator and a leader in the Grange and other fraternal orders, was born at Kennebunk, Feb. 2, 1857, son of William V. and Sarah Durrell Stevens. He attended Kennebunk schools, and for the greater part of his life he had resided in this town.

In early life he was a sea captain and was at one time a pilot on the Kennebunk River. Later he entered the hotel business, and operated the former Columbia Hotel and the Parker House at Kennebunkport.

It was during his seafaring career that he was caught in a dory during the great storm of No-

vember, 1898, in which the steamer Portland was lost, but he rode it out and came safely to port.

He had served in the Maine State Guard and was a member of the Kennebunkport School of Representatives and also a Seaman's Union member.

A past master of the Grange of the Pomona, he has been a member of the Knights of the Council and Ker Chapter, and a 19th Masonic Lodge, Knight of the school of which he was a member.

It was while he was a member of the Legislature that he introduced a bill for a nine-inch lobster law for York County, and it failed of passage by but few votes. Surviving are a son, Woodbury H. Stevens, Kennebunkport, and two grandchildren, Woodbury G. Stevens, Kennebunkport, and Mrs. Marilyn S. Palmee, Providence, R. I.

Funeral services will be held in Masonic Temple, Kennebunkport at 2 p. m. Tuesday. The Rev. Wilson Lyons will officiate. Interment will be in Evergreen Cemetery, Kennebunk Landing.



BOOTHBAY — James Perkins Stevens of Boothbay, noted ship builder, marine historian and genealogist, died peacefully with his family surrounding him at his home on the River Road in Boothbay on July 6, 2002.



James P. Stevens

He was born in Popham Beach on

March 16, 1916, the second son of Jacob Arthur and Ella Stacey Stevens. Mr. Stevens came to East Boothbay at the age of four and was a lifelong resident of the region. He attended Gould Academy in Bethel and graduated from Boothbay Harbor High School, Class of 1933.

On Jan. 1, 1936, he married Evelyn Thurston of Rumford Point, and together they had eight children.

Mr. Stevens began working with his father and older brother at Goudy & Stevens in East Boothbay. He spent the winter of 1940-41 as foreman at the Donaldson Shipyard in South Portland. During the early part of World War II, he was foreman at Camden Shipbuilding & Marine Railway Company in Camden. He returned to Goudy & Stevens in 1943, becoming a partner with his brother, the late Jacob "Tunk" Stevens, and his brother-in-law, the late Frank Cummings.

Mr. Stevens retired in 1987, devoting his time to marine history and genealogy, having written several articles and one book, "Reminiscences of a Boothbay Boatbuilder."

Throughout his life, he took an active role in community affairs and was a member of the following organizations: Crescent Chapter of Eastern Star and Bayview Lodge 196, lifetime member of each; Boothbay School Board; Maine Boatbuilders; past director, Bath Marine Museum; past director and one of the original founders of the Boothbay Region Historical Society.

Mr. Stevens was also awarded the lifetime service award from the Boothbay Harbor Rotary Club in 1991. He was inducted into the Maritime Boatbuilders Hall of Fame in 1994. He was recently the subject of an article "Fifty Years a Boatbuilder," published in the June 2002 issue of *WoodenBoat*.

Some of the notable ships that Mr. Stevens built were: 'The America,' launched in 1967; 'Sea Star,' launched in 1969 for Lawrence Rockefeller, and 'Cassiar,' launched in 1968 for the Mellon family.

Mr. Stevens was predeceased by his parents, brother, sister Eva, daughter Judith, grandson James Harvey, and great-granddaughter, Emily Ann.

He is survived by his devoted wife of 66 years, Evelyn Thurston Stevens, and their seven children: Joel B. Stevens and wife, Judy of Panama City, Fla., Elizabeth and husband Merle Smith of Farmington, Edith Stevens of Westbrook, Ella and husband William Ibarguen of Farmington, James Nathaniel Stevens and wife Barbara of Dresden, Jacob A. Stevens III and wife Margaret of Bristol, R.I., and Ellen and husband Robert Newton of Boothbay; 23 grandchildren; eight stepgrandchildren; 22 great-grandchildren; three stepgreat-grandchildren; and several cousins, nieces and nephews. He leaves many cherished friends as well.

Those who wish may make contributions in Mr. Stevens' memory to Boothbay Region Historical Society, Boothbay Harbor, Maine; East Boothbay Methodist Church, East Boothbay, Maine; and Popham Beach Chapel, Popham Beach, Maine.
