John Calvin Stevens, 84, prominent Portland architect, died Thursday evening in his home, 31 Craigie Street, after a brief illness with pneumonia. His wife, Mrs. M. Louise Stevens, 87, died last month.

Among the local buildings which Mr. Stevens designed were the Sweat Memorial Art Museum, the Portland Athletic Club, the New England Telephone and Telegraph Company plant, the Maine Eye and Ear Infirmary, the Oxford Building on Middle Street. In association with a New York firm, he prepared plans for Portland City Hall when it was rebuilt after the fire of 1908. He drew the plans for the rebuilding of the State Street Congregational Church and the remodeling of the Union Mutual Building and

designed the exterior of the Brown Block.

Much of Mr. Stevens' work was done in other communities of Maine. He was architect for many of the buildings at Togus, the Academy Building at Houlton, the academy and dormitory at Hebron, the Maine State Sanatorium at Hebron, many of the smaller Baptist churches throughout the state, the diningroom wing of the Poland Spring House, the hotel at Belgrade, the Eastern Maine Hospital for the Insane at Bangor, libraries at Houlton and Rumford, the remodeling of the south wing of the State House at Augusta and the Municipal Building at Skowhegan.

Mr. Stevens was a member of the Portland City Council from Ward Seven in 1900. He was a fellow of the American Institute of Architects, a member of the Boston Society of Architects, the New York Architectural League, the Salmagundi Club, the American Federation of Art, president of the Portland Society of Art, former president of the Portland Chamber of Commerce, former vice president of the Maine Charitable Mechanics' Association, a member of the National Municipal League, the Maine Genealogical Society, the American Civic Association and the Maine Association of Engineers. He also was a member of the Portland Club, the Rotary Club, an honorary member of the Portland Yacht Club, Maine Lodge, I. O. O. F., a life-member of Ancient Landmark Lodge of Masons and a 32nd Degree Mason.

Mr. Stevens was to have been elected president emeritus of the Portland Society of Art this month. He served his first term as its president in 1895. He was president of the Maine Charitable Mechanics' Association, 1890-91, president of the Portland Athletic Club in 1900, and president of the Portland Wheel Club, 1888-89. At one time he was a member of the Board of Trustees of the Maine Eye and Ear Infirmary.

One of the oldest active architects in the Country, Mr. Stevens enjoyed a nation-wide reputation. He was president of the Portland Chamber of Commerce in 1923. He was the Maine member of the American Institute of

JOHN HOWARD STEVENS

John Howard Stevens of 182 Craigie St., a Portland architect for 60 years, died here yesterday morning. He was 78.

Mr. Stevens was widely known for his designs, his interest in the Boy Scout movement, and participation in civic, cultural and professional groups. Probably his best-known buildings in Portland are the Post Office on Forest avenue and the Boys Club.

He was born here Feb. 23, 1879, the son of John Calvin Stevens and Martha Louise Waldron Stevens, was educated in public schools here and in 1898 joined the architectural firm his father founded 10 years previously.

At various times he was president of numerous organizations, including the Portland Rotary Club, Chamber of Commerce, Society of Art, Maine Chapter, American Institute of Architects and the Maine Association of Engineers. He was a vice president and director of the Boys Club, a director of Pine Tree Council, Boy Scouts of America, and a trustee of the Portland Public Library.

During World War 1 he was chairman of the transportation corps of the American Red Cross. In the 1930's, he headed the American Historical Building Survey in Maine, New Hampshire and Vermont. He was instrumental in establishing Camp William Hinds for the Boy Scouts and some years ago received the Silver Beaver award from the Scouts for distinguished service to boyhood.

Mr. Stevens was a member of the First Universalist Church and Ancient Landmark Lodge, AF&AM. He had been a member of the architectural firm of Stevens and Saunders since 1953.

He leaves his widow, Mrs. Agnes S. Stevens; two sons, John Calvin Stevens II, Cape Elizabeth, and Howard Winchester Stevens, Westbrook; three sisters, Mrs. Henry K. Fitts, Winchester; Mass., and Mrs. Neal W. Allen, and Miss Dorothy Stevens, Portland; four grandchildren, David W. and William V., Westbrook, and Paul S. and Joel W., Cape Elizabeth; and several nieces and nephews.

Funeral services will be held at 3 p.m. tomorrow at 749 Congress St. with the Rev. James W. Lenhart officiating. Burial will be in Evergreen Cemetery.

Funeral services for one of Portland's best known druggists will be held at 1:30 p.m. Wednesday at 749 Congress St. John Mahlon Stevens, 86, of 79 Bay View Dr., died Saturday evening in a local nursing home. He had been in failing health for weeks.

Mr. Stevens was a druggist at Woodfodrs Corner more than a half century. He became associated with the Frank Moody drugstore there in 1895, bought the business in 1902. He operated it until Jan. 16, 1946, when he sold out to Wilfred A. Houle and retired.

Mr. Stevens was born May 25, 1872 at North Windham, son of Hannah Ellen and John Stevens. He attended Windham schools and was graduated from Windham High School and Gray's Portland Business College.

While he was still in high school, Mr. Stevens started

work for Heseltine & Tuttle Co., retail druggists. He remained with that firm for seven years until he became associated with the Moody drugstore.

Mr. Stevens was a 32nd Degree Mason, a life member of Deering Lodge, AF&AM, which he joined in 1903, a member of St. Alban Commandery, Knights Templar, and of Greenleaf Chapter, RAC.

On Oct. 2, 1919, he married Isabel C. Clark, daughter of Capt. and Lyman E. Clark of Portland.

Besides her, he is survived by a niece, Jeanett Mercier, Boston, and a nephew, Ardon C. Mercier, Schenectady, N. Y.

He lived in Connecticut and New York City for many years, and then moved back to Unity to retire from Lever Brothers, in New York City, where he had been national accounts manager, marketing sales and public relations.

Mr. Stevens was predeceased by his son, Joseph Libby Stevens, in 1974, who was the son of his first wife, Marie Brennan (Stevens) Pelikan, and his wife Mary Roback Stevens, in 1988.

Surviving him are his daughter, Jane Libby Stevens Pinnette, and her husband, Daniel Henry Pinnette; his grandson, David Joseph, "D.J." Pinnette; his adopted daughter, Anne Libby Edwards, his daughter Jane's half sister, and her family, James Costanzo, his daughter Jane's half brother; his grandson, D.J.'s, half brothers, Dana L. Pinnette, and Danny A. Pinnette; and other extended family members; and close friends.

Dean Of Maine Insurance Agents Dies Here At 82

J. Putnam Stevens Succumbs After Long Illness

ILL AT HIS HOME several months, J. Putnam Stevens, 82, one of Maine's most prominent general insurance agents, died this afternoon.

Mr. Stevens, general agent here for the Massachusetts Mutual Life Insurance Company for nearly 50 years, was dean of life insurance men in this State in point of age and service and was the dean of agents in the United States for his company.

Native of Winthrop

A native of Winthrop, where he was born Nov. 24, 1852, the son of Joseph Warren and Mary Ingalls Stevens, he made his home in Portland many years, becoming prominent in civic and fraternal circles as well as in its business life.

In 1905-1906 Mr. Stevens served as a representative to the Legislature, and in 1911-1912 was a member of the Portland School Board.

For many years he was the only

Robert L. Stevens, 73, of Brackett Avenue, Peaks Island, a direct descendant of the Mayflower Pilgrims, died Saturday in a Portland nursing home.

PASSAGES

Every day the Press Herald selects one obituary and seeks to learn more about the life of a person who has lived and worked in Maine. We look for a person who has made a mark on the community or the person's family and circle of friends in small but lasting ways.

"He was a Brewster man," descended from Elder William Brewster, one of the 102 passengers who sailed aboard the Mayflower in 1620, said Henry Adamson, a neighbor and longtime friend.

Mr. Stevens also was able to trace his ancestry to one of the signers of the Magna Carta in 1215.

Adamson said Mr. Stevens was extremely proud of his heritage. He served as national officer and board member of the National Society of

Mayflower Descendants, and was past governor of the State of Maine Society of Mayflower Descendants. Most recently, Mr. Stevens served as treasurer and, at the time of his death, was named treasurer emeritus.

He also was a life member of the Magna Charta Barons and the Descendants of Colonial Clergy.

Mr. Stevens, who had lived on Peaks Island since 1930, also belonged to numerous civic organizations. He served as president of the Peaks Island Council and was elected chairman of the Republican City Committee during the 1960s.

He also was a charter member of the Peaks Island Lions Club, served on the board of Opportunity Farm, was a member of the Forest City Grange of Peaks Island and had served as treasurer of the Portland Executive Club.

Mr. Stevens served one term on the Casco Bay Transit District, was a member of the Maine Charitable Mechanics Association and was a former treasurer of the Brighton Medical Center.

He was a former past grand master of the Grand Lodge of Maine of the Odd Fellows, a past member of the Portland Rotary Club and the Cumberland Club. He was also a member of the Triangle Lodge of Masons, Scottish Rite Bodies of Portland, Kora Temple Shrine of Lewiston and the Presumpscot Lodge of Odd Fellows.

He also was a former deputy commander of the Maine Wing of the Civil Air Patrol. He was a member and past treasurer of the Peaks Island Brackett Memorial Church.

Mr. Stevens was the owner of the former Frost Mimeograph, Portland. Since his retirement, he had worked as a part-time bookkeeper for the Child Development Center on Peaks Island.

He was born in South Portland, a son of George L. and Lila Cobb Stevens, graduated from Portland High School and attended Gray's Business College.

There are no known survivors.

A memorial service will be held at 3 p.m. Sept. 10 at the Brackett Memorial Church, Peaks Island. Burial will be in the family lot in Maple Grove Cemetery, Mechanic Falls. Arrangements are by the Jones, Rich & Hutchins Funeral Home.


